

TOWN AND COUNTRY PLANNING GENERAL REGULATIONS 1992

Written Notice Pursuant to Regulation 6 (1) of the 1992 Regulations of development authorised by the Director of Transport and Environment.

TAKE NOTICE that under the powers delegated to me by the County Council meeting held on 18 May 1999 I have authorised the development described in Schedule 1 hereto, pursuant to Regulation 3 of the Town and Country Planning General Regulations 1992, subject to the conditions set out in Schedule 2 hereto.

SCHEDULE 1

EB/2130/CC - Removal of one single prefabricated classroom and installation of one double prefabricated classroom Eastbourne Technology College, Brodrick Road, Eastbourne (within area edged red on applicant's plan no. 374230/8/A/P52).

SCHEDULE 2

1. The building hereby permitted shall be removed from the site and the land restored to its former condition on or before the 1 August 2006.

Reason: To comply with Section 91 of the Town and Country Planning Act 1991.

- 2. No development shall take place until there has been submitted to and approved in writing by the Director of Transport and Environment a scheme of minimisation, reuse and recycling of waste material generated during construction of the development hereby approved. This statement should include site specific and detailed information concerning the ways in which:
 - a) The development maximises the reuse of existing buildings and new buildings are designed and constructed so as to maximise the lifespan of the development;
 - b) The development incorporated construction practices that minimise the use of raw materials and maximise the use of secondary aggregates and recycled materials where appropriate;

- Waste material generated by the proposal is minimised and reused or recycled c) where appropriate on site (for example in landscaping proposals) or removed from the site to facilities which can reuse or recycle the materials; and,
- Where appropriate, the development includes the provision of temporary d) facilities on or adjacent to the site during demolition and/or construction phase to sort the waste produced in order to minimise the amount of waste that will need to be removed from the site for final treatment or disposal.

Reason: In the interests of encouraging a sustainable approach to construction waste and to comply with Structure Plan policy W10 and policy WLP11 of the Second Deposit Waste Local Plan (April 2002).
