



# TOWN AND COUNTRY PLANNING GENERAL REGULATIONS 1992

Written Notice Pursuant to Regulation 6 (1) of the 1992 Regulations of development authorised by the Director of Transport and Environment.

TAKE NOTICE that under the powers delegated to me by the Governance Committee meeting held on 30 January 2003 I have authorised the development described in Schedule 1 hereto, pursuant to Regulation 3 of the Town and Country Planning General Regulations 1992, subject to the conditions set out in Schedule 2 hereto.

#### SCHEDULE 1

LW/2363/CC - To erect a conservatory in the rear of the property. Newick School, Allington Road, Newick (within land edged red on applicants site plan scale 1:1250).

#### SCHEDULE 2

- 1. The development hereby permitted shall be commenced before the expiration of five years from the date of this permission.
- Reason: To comply with Section 91 Town and Country Planning Act 1990.

  The brick to be used on the conservatory should match the red brick used on the main school

Reason: To help ensure an appropriate appearance of the conservatory in relation to the main school in accordance with policy EN1 in the East Sussex and Brighton & Hove Structure Plan 1991 - 2011 and policy ST3 of the Lewes District Local Plan 2003

3. Any inert waste material generated by excavation for foundations shall be spread around the school grounds and not taken off site.

Reason: To recycle waste generated during construction in accordance with policy W10 of the East Sussex and Brighton & Hove Structure Plan 1991 - 2011 and WLP11 of the East Sussex and Brighton and Hove Waste Local Plan: Second Deposit April 2002.
