



TOWN AND COUNTRY PLANNING ACT 1990

TOWN AND COUNTRY PLANNING GENERAL REGULATIONS 1992

Written Notice Pursuant to Regulation 6 (1) of the 1992 Regulations of development authorised by the Director of Transport and Environment.

TAKE NOTICE that under the powers delegated to me by the County Council meeting held on 18 May 1999 I have authorised the development described in Schedule 1 hereto, pursuant to Regulation 3 of the Town and Country Planning General Regulations 1992, subject to the conditions set out in Schedule 2 hereto.

SCHEDULE 1

LW/333/CC/8 — Retention of two storey mobile building. Lewes Library, Albion Street, Lewes (within land edged red on applicants plan no. Ref. 1).

SCHEDULE 2

The building hereby permitted shall be removed and the land restored on or before 30 September 2005 in accordance with a scheme submitted and approved in writing by the Director of Transport and Environment.

Reason: To ensure the removal of this temporary structure, in the interests of visual amenity and to comply with policies S1 and EN1 of the East Sussex and Brighton & Hove Structure Plan 1991-2011 and ST3 of the Lewes District Local Plan, Adopted March 2003.

2. The eastern elevation of the attached listed building shall be restored to its appearance before the attachment of the temporary building with materials and finishes to match the existing listed building. Such works shall be completed no later than one month after the removal of the temporary structure.

Reason: To ensure that any damage caused to the listed building as a result of the temporary building is restored to its former condition in the interests of

the conservation of the listed building, and to comply with policies EN26 of the East Sussex and Brighton and Hove Structure Plan 1991-2011 and H2 of the Lewes District Local Plan Adopted March 2003.
