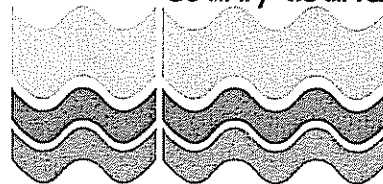

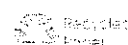

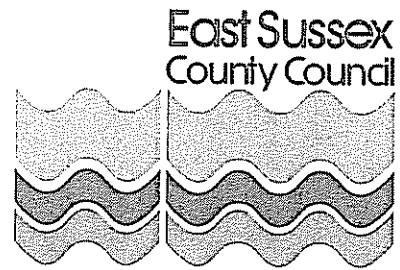

TAKE NOTICE that under the powers delegated to me by the County Council meeting held on 18 May 1999 I have authorised the development described in Schedule 1 hereto, pursuant to Regulation 3 of the Town and Country Planning General Regulations 1992, subject to the conditions set out in Schedule 2 hereto.

SCHEDULE 1

Demolition of existing mobile unit, installation of new single mobile unit at same location. Battle and Langton CE Primary School, Market Road, Battle (within land edged red on applicant's plan no. 376270/2/A/P101)/

SCHEDULE 2

1. The development hereby permitted shall be begun before the expiration of five years from the date of consent.

Reason: To comply with Section 91 from the Town and Country Planning Act 1990.

2. The development hereby approved shall be removed, and the land restored to its former condition, within 5 years from the date of consent.

Reason: To enable the County Planning Authority to control and regulate the development.
