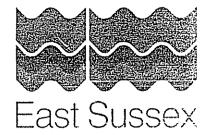

Town and Country Planning General Regulations 1976

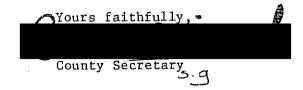
"the development hereby permitted must be begun before the expiration of the period of five years beginning 14 November 1984".
