Description: The construction and use of plant, namely aggregate processing plant, aggregate bagging plant, concrete batching plant, concrete block-making plant and buildings, ancillary offices and stores for processing and utilising aggregates landed at Newhaven Port and distribution of the products by road and rail together with access to the public highway and the extension of an existing rail siding.

Comments: I object to this development because it will have an adverse effect on the whole of Seaford Bay. It will not only be an eyesore, but it will also cause a great deal of pollution, noise and heavy traffic on the ring roads in Newhaven near the Bridges. Important habitats for the wildlife will be damaged and destroyed, including the natural habitat of Tide Mills and the shoreline, as well as sites of historical importance. This will ultimately mean less tourism in the area (and Newhaven is already struggling because of lack of tourism already because of no shops and a under developed town center), also which will mean fewer jobs on the long term and will destroy any chance of Newhaven ever regenerating as a pleasant place to live (and will become another Jaywick by sea of England). My stepdaughter and her family purchased their house and most of the residence of Badgers Close purchased the new houses in our Badger Close road due to the sole purpose of the scenic view of Seaford beach and Cliff from our windows and if the construction of this plant goes ahead the house prices and view will be gravely affected directly and blocked. This can cause all the house prices to fall in the whole of Hillcrest Road, West Quay side and Badgers Close Road of Newhaven.
