Town and Country Planning Act 1990 Relating to land known as A259 Belle Hill, Bexhill on Sea to B2092 Queensway, St. Leonards on Sea, East Sussex RR/247/CC(EIA) — Conditions 9, 10 and 20 - Temporary Construction Works, Wheel Wash Facilities and Maintenance of Rights of Way.

I am writing to request approval to use an alternative route through Glovers Lane for transporting plant and welfare facilities on to site. In order that the ground treatment works can be carried out, 1no. low loader, 1no. hiab and 1no. flat bed vehicle shall be used. In addition to these vehicles, we are also looking to use this route to bring in welfare facilities to be located at Glovers Farm, as indicated on Drawing No. V003/005 Rev 12. There shall be 4no. hiabs carrying these welfare units.

The reason we need to use an alternative access route through Glovers Lane is due to the height restrictions at Ninfield Road Bridge, preventing use of the access from the Elva Way entrance, but also the gradient of the haul road through Decoy Pond restricts entry from the Hastings end of the scheme.

The necessity to use the Glovers Lane access route would be between 10:00am - 15:00pm on either Monday 07th April or Tuesday 08th April 2014, but only one of the days will be used.

A letter drop will be carried out to the residents along Glover Lane as per previous occasions that we have used this route for access.

In addition to seeking approval to use an alternative route, we also hereby submit the following amended details, reserved by Conditions 9, 10 and 20, for approval:

- Drawing No. V003/005 Haul Road, Temp. Water Crossings & Compound Locations (Sheet 1 of 3) – Rev 12.
- Drawing No. V003/006 Haul Road, Temp. Water Crossings & Compound Locations (Sheet 2 of 3) – Rev 10.
- Drawing No. V003/007 Haul Road, Temp. Water Crossings & Compound Locations (Sheet 3 of 3) – Rev 13.

This application is made on behalf of the Assistant Director – Transport and Operations, East Sussex County Council and the relevant cost code for payment of fees due is C.5.04.200.2
