Good morning.

Please find attached marked drawings showing planting progress made up to 10/02/15. All the planting drawings were recently reissued as Rev C4 with minor changes to drawings 0001, 0002 & 0004-0014. More significant changes were made on drawings 0003 and 0015-0017.

The marked progress drawings however are still based rev C3 as the changes to drawings 0001-0002 & 0004 - 0014 are very minor with changes being implemented on site as works progress. I have included drawing 0003 rev C4 and will continue using this in future updates. Progress for drawings 0015-0017 are also shown on rev C3 with some notes on the drawings. I have not included drawing 0001 as this has been superseded following the issue of Belle Hill Planting drawings (0015-0017).

Green highlighted were completed in 2014/2015 & purple highlighted show progress made since returning in 2016. Areas that require completion of earthworks to enable planting works are highlighted in red and the aim is to complete earthworks to these areas by end of March '16 or sooner, weather permitting.
