No. However information supplied indicates a trench foundation design to a depth of c. 650mm. It is unclear to what depth the current hard-standing has disturbed archaeological remains. Given the sites potential there will be a requirement for archaeological monitoring and recording secured by an appropriate planning condition.

No – the site is surrounded by five listed houses dating from 17<sup>th</sup> century to 19<sup>th</sup> century but none are likely to be impacted by the development.

**8. Archaeological / historical background**

Has the County Historic Environment Record (HER) provided information regarding the site and its immediate surrounding?

Yes

Summary of HER results.

Beckley is a known early medieval market village. The site lies in the centre of the area of the probable Saxon settlement. The site lies within the Archaeological Notification Area due to the likely survival of medieval and post medieval remains in the area. Historic mapping shows the school and listed buildings surrounding but that the footprint of the site has not been developed in the 19<sup>th</sup> or 20<sup>th</sup> centuries.

### **9. Recent past impact / archaeological potential of site**

Provide a brief summary of past impact or disturbance to site, which may influence archaeological potential of site.

The original brick-built Victorian school building has had much more recent, flat-roofed extensions to the rear of the school, adjacent the playground and proposed location of the temporary classroom. The original building and subsequent extensions sit on finished ground level that is lower than the playground, therefore the foundations and services excavated for the proposed temporary classroom will likely extend to a lesser depth than those of the existing, permanent building on the site.

### **10. Proposed impact**

Provide a summary (including where available plans and sections) of proposed below ground impacts, (e.g. size / depth of foundations / ground reduction, service connections) and or impact on the structure of an above ground heritage asset such as a building or earthwork.

The above plan drawing shows the probable extent of the 500x650mm concrete foundations required beneath the proposed mobile classroom.

The plan also shows the provisional design for new surface and foul drain connections to serve the proposed temporary classroom. These shall be to varying depths (to engineer design) and will discharge into the existing drains on the site. To that end, the excavations for such shall be no deeper than the below ground services already found on the site.

## **10. Proposed Impact (Continued)**

The proposed classroom building shall require connection to services already supplied to the site; water and electricity and phone/data. These will be to engineer design which can be confirmed to the LPA at a later date as part of any conditions of approval that are deemed necessary. In the interim, we confirm that the engineer shall seek to minimise the extent of depth of any excavation to enable the supply of these buried services, and combine them in a single trench if at all possible.


