Town and Country Planning Act 1990 Relating to land known as A259 Belle Hill, Bexhill on Sea to B2092 Queensway, St. Leonards on Sea, East Sussex RR/2474/CC(EIA) – Condition 11 (Out of Hours Working).

Following receipt of your approval letter (Ref:RR/2474/CC(EIA)GM/SLI) dated 09/05/2014, related to works at Belle Hill junction and London Road, we are writing to request out of hours working in order to continue with the essential tie-in works at the following times:

- Monday 19th May 19:00hrs – Tuesday 20th May 04:00hrs;
- Tuesday 20th May 19:00hrs – Wednesday 21st May 04:00hrs;
- Wednesday 21st 19:00hrs – Thursday 22nd May 04:00hrs;
- Thursday 22nd May 19:00hrs – Friday 23rd May 04:00hrs; and
- Friday 23rd May 19:00hrs – Saturday 24th May 04:00hrs.

The proposed works to be carried out include ducting works for the traffic signals and the utility diversion work of a South East Water main. The reason the works are proposed to be carried out during the above hours is to minimise the disruption caused to the local road users.

As has been agreed on previous occasions, the 'noisy' works shall terminate at 02:00hrs each morning, with the remaining two hours being used to remove the traffic management and clear the site away. The traffic management shall consist of two-way traffic lights on London Road North.

The lighting to be used shall be the same type as previously approved (light towers powered by a generator), with the light facing away from residential properties and towards the works.

The planned plant and equipment involved in the operations shall be as follows:
