As discussed, and as stated as a requirement in your letter dated 15<sup>th</sup> December 2015, please find attached an update on our progress for Greenways, landscaping and fencing.

The attached drawing has been highlighted showing work done since the 15th Feb 2016 for the Greenway construction. The information below provides some accompanying information.

Updates for the landscaping have been sent via separate emails by Ryno Harmse.

### **Greenways – Condition 8**

The section of Greenway adjacent to Crowhurst Road Underpass to the site compound has been completed, however the surfacing dressing has not been placed. A small section of greenway, where it crosses our site entrance, will be completed at later date. This is planned to be when we have demobilised the site compound.

This section of Greenway will be open for public use from the 16th March 2016.

The application of this surfacing dressing is currently being reviewed, and is likely to be planned to tie in with visits for other sections of completed Greenway.

Please also refer to the attached drawing for other sections of Greenway that have been worked on during this period.

### **Fencing - Condition 13**

The only fencing works that have been completed since 15/02/16 has been the installation of a gate on the track going up to Hillcroft Farm in order to stop vehicles using this track.

Lifebuoy stations have also been installed at Ponds H1 to H6.

Programme/plans for the completion of the fencing remains as detailed in your letter to us dated 15<sup>th</sup> December 2015. (i.e. end of May 2016)
